The City Council presented their views on the candidate they were interested in for the position of the City Administrator for the City of Winsted.

Council Member Fasching motioned to direct Mr. Gary Weiers to offer the City Administrator position for the City of Winsted to Mr. Daniel Tienter. Council Member Schulenberg seconded the motion. Motion carried 4-0.

The City Council discussed and gave direction on the salary range that they would like Mr. Weiers to negotiate with Mr. Daniel Tienter.
