b) Schedule Public Hearing – Fee Schedule Ordinance *

Schedule a public hearing for January 5, 2016 at 6:00 p.m. to consider adopting amendments to the Fee Schedule Ordinance.

c) 2016 Property and Casualty Insurance Renewal Contract: Liability Insurance Coverage – Waiver Form

Authorize the City of Winsted to not waive the monetary limits on municipal tort liability established by Minnesota State Statutes 466.04 for the 2016 Property and Casualty insurance contract.

d) 2016 Property and Casualty Insurance Renewal Contract: No-Fault Sewer Back-Up Insurance Coverage *

Authorize the City of Winsted not to purchase No-Fault Sewer Back-Up insurance coverage for the 2016 Property and Casualty insurance contract.

e) 2016 Property and Casualty Insurance Renewal Contract: Excess Liability Insurance *

Authorize the City of Winsted to purchase \$1,000,000 in excess liability coverage for the 2016 Property and Casualty insurance contract.

f) Cancellation - Preferred One Insurance

Approve the cancellation of the City's health insurance for employees provided by Preferred One, with the last day of coverage from Preferred One being December 31, 2015.

g) Blue Cross/Blue Shield –Small Group Employer Application

Approve a Small Employer Enrollment Form with Blue Cross/Blue Shield Insurance.

Approve the renewal of dental insurance with Delta Dental for full time employees of the City of Winsted.
